If you are between the ages of **17 and 21 as of January 1st, 2010** you are eligible to apply for the **Manitoba 4-H Judging Team!** Agribition 2010 will be held from November 21st - 28th in Regina. The **Canadian National 4-H and Youth Judging Competition will take place from 21st to 23rd.**

This year we are trying something new!! All those interested in being on the Manitoba 4-H Judging Team should **apply via this application** and send to Manitoba 4-H Council Office by **February 15th, 2010.** Manitoba 4-H can send a team of four to eight members to Agribition. A MAFRI chaperone will go with the team to Agribition. We are committed to assisting and training our team to be ready for the event. This is why we are selecting our team a year in advance. For **2010 ONLY we will be selecting our team through this application process.** In the past we have selected the Agribition Judging Team at Stockfest and this only gives the team about two months to prepare for the event. By selecting the team a year in advance, 4-H members will have adequate time and opportunities to practice and prepare for the event. At Stockfest 2010, we will select our team for 2011. At Stockfest 2011, we will select our team for 2012.
